# VII.E. Approve Mileage Reimbursement Rate for 2015-16

As per the negotiated agreement, any teacher traveling between campuses during the school day to provide instruction is to be paid approximately 90% of the IRS mileage rate as of July of each year. As of July 1st, the IRS mileage rate for business use is at \$.575/mi. Ninety percent of \$.575/mi is rounded to \$.52/mi.
